




# Gamers Holding Crypto (In Millions)



Gamers are also much more likely to own crypto as compared to others- 55% of the Millennials gamers own crypto as compared to just 5% of all Millennials.



### **Global Gaming and Crypto Revenue**




### Revenue generated by Hyper Casual Games


### Number of Sales Copies Sold of Top 5 Games, 2022




